## Notes on Completion of this Form

**Please read these notes carefully before completing this form.**

Since the introduction of the 2014 scheme, all Local Government Pension Schemes (LGPS) need to keep a record of each member's previous pension rights with other LGPS or public service pension schemes.

Therefore please declare if you have any period of employment with the following employers. This will help us give you your correct options and ensure any protections are correctly recorded.

- Local Government - England, Scotland or Wales (**Please see note 3**)
- The Civil Service
- The Judiciary
- The Armed Forces
- Teachers
- The National Health Service
- Police
- Fire and Rescue

### **Please Note:**

1. We may contact you by e-mail in the future.
2. Please note all transfers must be applied for within 12 months of joining your employer. If you have ticked 'Yes' to investigate a possible transfer of pension rights you must also complete a Transfer Authority Form for each individual pension provider.
3. If you have any other pension rights in the LGPS in England and Wales, your membership may be automatically aggregated (combined) after 12 months, **unless** you elect to keep your periods of membership separate within the 12 months of joining the Cheshire Pension Fund. We will write to you with your options.
4. Declaring an interest in possibly transferring your pension benefits into the Cheshire Fund does not commit you to the transfer (except for those members where point 3 applies). You will only be committed to the transfer after you have received a transfer quotation and have confirmed in writing that you wish to proceed with the transfer.

### **Transfers from other pension providers**

If you have previously paid into a company, occupational or personal pension scheme or had an Additional Voluntary Contributions (AVC) arrangement before you joined the Local Government Pension Scheme (LGPS) you may wish to investigate transferring these into the Cheshire Pension Fund.
